# House & Senate Bill Descriptions

## **A = House Bill 29: Criminal Activity Involving Use of Utilities for Manufacturing Controlled Substances (2009) -** *(Supported by the Christian Coalition of Florida)*

Provides criminal penalties for permitting tenant or occupant to use unlawfully connected utility services; provides that violation is first-degree misdemeanor; provides for prima facie evidence of intent to violate such prohibition; provides that theft of utility services for purpose of manufacturing a controlled substance is first-degree misdemeanor; provides for prima facie evidence of intent to commit theft of utility services for purpose of manufacturing controlled substance. [\(This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-159\)](#)

## **B = House Bill 115: Public Safety from Sexual Offenders and Predators (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Encourages all public libraries to implement an Internet safety education program for children and adults; requires sexual offenders & predators to provide home telephone numbers & any cellular telephone numbers as part of registration process; corrects references relating to exclusions from sexual offender or predator designation; removes residency requirements in statutes relating to computer pornography involving minor children, etc. [\(This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-194\)](#)

## **C = Senate Bill 160: Criminal History Screening Relating to Sports Coaches (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Defines the terms "independent youth athletic team," "minor," and "sports coach." Requires the sanctioning authority of an independent youth athletic team to screen an applicant for sports coach through designated public websites maintained by the FDLE and the United States Department of Justice. Provides that a background screening in compliance with the federal Fair Credit Reporting Act satisfies screening provisions, etc. [\(This bill passed the Florida Senate, and died in the Florida House\)](#)

## **D = Senate Bill 168: Florida Statewide Task Force to Prevent Human Trafficking (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Creates within the Department of Children and Family Services the Florida Statewide Task Force on Human Trafficking. Requires that the task force prepare a final report by a specified date. Provides duties of the Florida State University Center for the Advancement of Human Rights, etc. [\(This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-95\)](#)

## **E = House Bill 239: "Choose Life," etc. Specialty License Plates for Motor Vehicles (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Limits use of proceeds from sale of specialty license plates; revises provisions for Choose Life license plate, and other license plates; provides for voluntary contribution to Autism License Plate Fund & Ronald McDonald Houses of Florida; revises period after which license plate must be replaced & conforms fees; removes requirements for size & construction of license plates & validation stickers; revises purpose of fee collected on vehicle registration or renewal; provides for display of license plates on wreckers, etc. [\(This bill passed the Florida House, and died in the Florida Senate\)](#)

## **F = Senate Bill 324: Relating to Internet Safety in Public Libraries (2009) -**

*(Supported by the C. C. of Florida)*  
Encourages all public libraries to implement an Internet safety education program for children and adults. Provides minimum requirements for the program. Requires libraries to annually report to the Division of Library and Information Services of the Department of State the number of participants who complete the program. Requires that the division adopt rules to award additional points to grant applicants implementing such a program. [\(This bill passed the Florida Senate, and died in the Florida House\)](#)

## **G = House Bill 381: "Give Grandparents & Other Relatives a Voice Act" (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Requires that case record of child under supervision or in custody of DCFS be maintained in complete & accurate manner; expands list of persons or entities that have access to child abuse records; renames "children's zones" as "children's initiatives"; revises provisions relating to strategic community plan; provides for reappropriation of funds, etc. [\(This bill passed the Florida House, the Florida Senate and was approved by the Governor into Law; Chapter No. 2009-43\)](#)

## **H = Senate Bill 448: Prohibits Sexual Activities Involving Animals (2009) -**

*(Supported by the C. C. of Florida)*  
Provides definitions. Prohibits knowing sexual conduct or sexual contact with an animal. Prohibits specified related activities. Provides penalties. Provides that the act does not apply to certain husbandry, conformation judging, and veterinary practices. [\(This bill passed the Florida Senate, and died in messages to the House\)](#)

## **I = House Bill 453: Tax Credits for Contributions to Nonprofit Scholarship-funding Organizations (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Provides that credit authorized under Florida Tax Credit Scholarship Program does not apply to credit for Florida alternative minimum tax; expands & renames Corporate Income Tax Credit Scholarship Program to include insurance premium tax credits; revises credits for contributions to nonprofit scholarship-funding organizations; provides that taxpayer eligible to receive credit against insurance premium tax is not eligible to receive credit against corporate income tax; imposes additional requirement upon DOE; specifies school district tax credit scholarship notification requirements & limitations; provides for credits against insurance premium tax for contributions to specified eligible nonprofit scholarship-funding organizations; authorizes certain insurers that made past contributions to Florida Tax Credit Scholarship Program to claim credits against future corporate income tax liability; etc. [\(This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-108\)](#)

## **J = House Bill 597: Relating to Preventing Homelessness and Caring for Children Leaving Foster Care (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Revises, provides & deletes definitions; increases & revises membership on Council of Homelessness; removes member from obsolete organization; creates Housing First program; provides components of program; provides that local continuums of care that adopt program be given funding priority; provides legislative findings & intent relating to young adults leaving foster care, etc. [\(This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-164\)](#)

## **K = House Bill 659: Reclassification of Sexual Misconduct with Students by Authority Figures (2009) -**

*(Supported by the Christian Coalition of Florida)*  
Provides for reclassification of specified sexual offenses committed against students by an authority figure. [\(This bill passed the Florida House, and died in messages to the Florida Senate\)](#)

## House & Senate Bill Descriptions continued:

**L = Senate Bill 788: Initial Floor Vote on the Indian Gaming Compact between the State of Florida and the Seminole Tribe of Florida (2009) - (Opposed by the Christian Coalition of FL)**  
See "M" (This bill passed the Florida House, the Florida Senate)

**M = Senate Bill 788: Final Passage of the Indian Gaming Compact between the State of Florida and the Seminole Tribe of Florida (2009) - (Opposed by the Christian Coalition of FL)**  
Provides terms and conditions for a gaming compact between the State of Florida and the Seminole Tribe of Florida. Removes an exception to the required issuance date of licenses to conduct thoroughbred racing performances. Provides that the payout percentage of a slot machine gaming facility must be at least 85 percent. Revises requirements for initial issuance of a cardroom license, etc. (This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-170)

**N = Senate Bill 836: Authorizes Electronic Gaming Machines (2009) - (Opposed by the Christian Coalition of Florida)**  
Authorizes electronic gaming machines in certain pari-mutuel facilities and authorizes the Div. of Pari-mutuel Wagering to issue licenses for electronic gaming. Prohibits persons who are younger than 18 years of age from playing electronic gaming machines. Provides for the additional tax that a municipality may access for live racing to apply to additional specified games. (This bill was "Laid on the Table" in the Senate and did not pass)

**O = House Joint Resolution 919: Revision of the Class Size Requirements for Public Schools (2009) - (Supported by the Christian Coalition of Florida)**  
Proposes amendment to s. 1, Art. IX & creation of s. 31, Art. XII of State Constitution relating to class size requirements for public schools. State Constitution currently limits maximum number of students assigned to each teacher in public school classrooms in the following grade groupings: for pre-kindergarten through grade 3, 18 students; for grades 4 through 8, 22 students; & for grades 9 through 12, 25 students. Under amendment, current limits on maximum number of students assigned to each teacher in public school classrooms would become limits on average number of students assigned per class to each teacher, by specified grade level, in each public school, etc. (This bill passed the Florida House, and died in the Florida Senate)

**P = Senate Bill 1248: Initial Floor Vote on Instructional Materials for Public K-12 Education (2009) - (Supported by the Christian Coalition of Florida)**  
See "R" (This bill passed the Florida House, the Florida Senate)

**R = Senate Bill 1248: Final Passage of Instructional Materials for Public K-12 Education (2009) - (Supported by the Christian Coalition of Florida)**  
Deletes a provision that requires a public school principal to collect 50 to 75 percent of a textbook's purchase price from a student who has lost, or damaged a textbook that has been used for more than 1 year. Requires the DOE to encourage school districts to initiate, and adopt service learning programs, and activities in grades K-12. Service-learning activities foster academic achievement, character development, civic engagement, and career exploration and enable students to apply curriculum content, skills, and behaviors taught in the classroom. (This bill passed the Florida House, the Florida Senate, and was approved by the Governor into Law; Chapter No. 2009-222)

**S = Amendment to House Bill 5001: Amendment to Allow State Funding of Embryonic Stem Cell Research (2009) - (Opposed by the Christian Coalition of Florida)**  
This Amendment offered by Representative Sands to the Appropriations Bill would have allowed state funds to be appropriated to support embryonic stem cell research which destroy human embryos. (This Amendment was defeated)

**T = House Bill 7145: Relating to Pari-Mutuel Permitholders (2009) - (Opposed by the Christian Coalition of Florida)**  
Revises provisions for permits, and licensing to conduct quarter horse race meetings; revises authorization to substitute races of other breeds of horses; allows for operation of cardroom 24 hours a day; revises license fee & tax rate for slot machine licensees; etc. (This bill passed in different forms from the Florida House, & Senate, and died in the conference committee)
